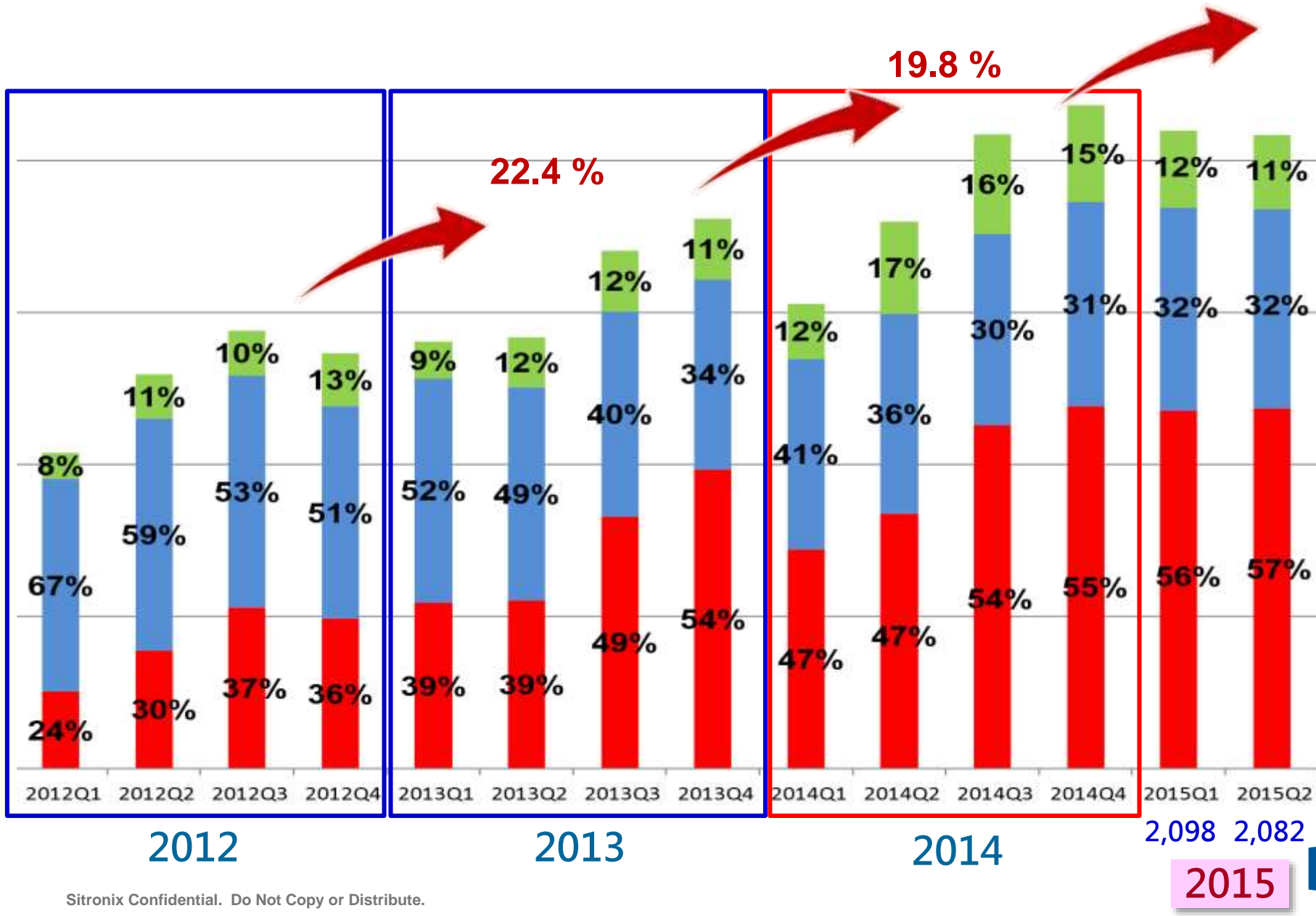

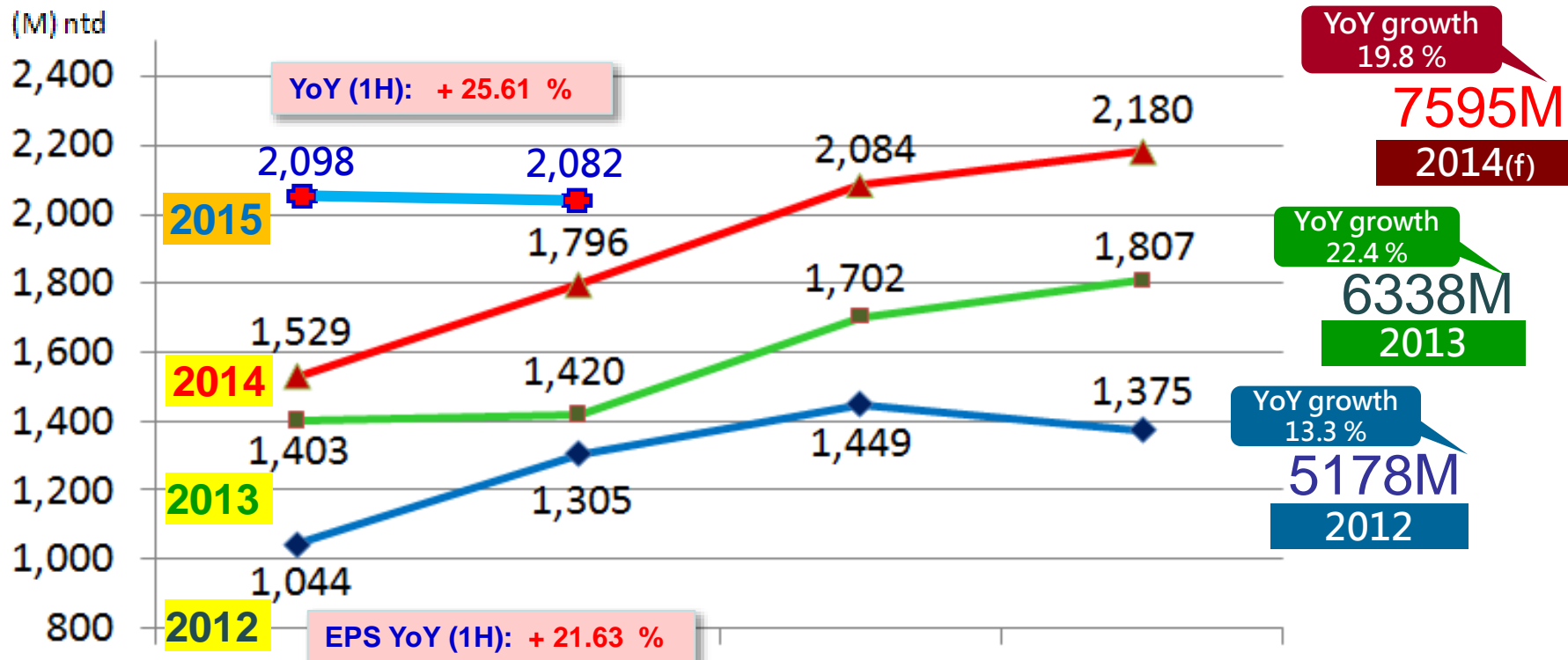

Revenue by product mix (Quarterly) 季營業額依產品別

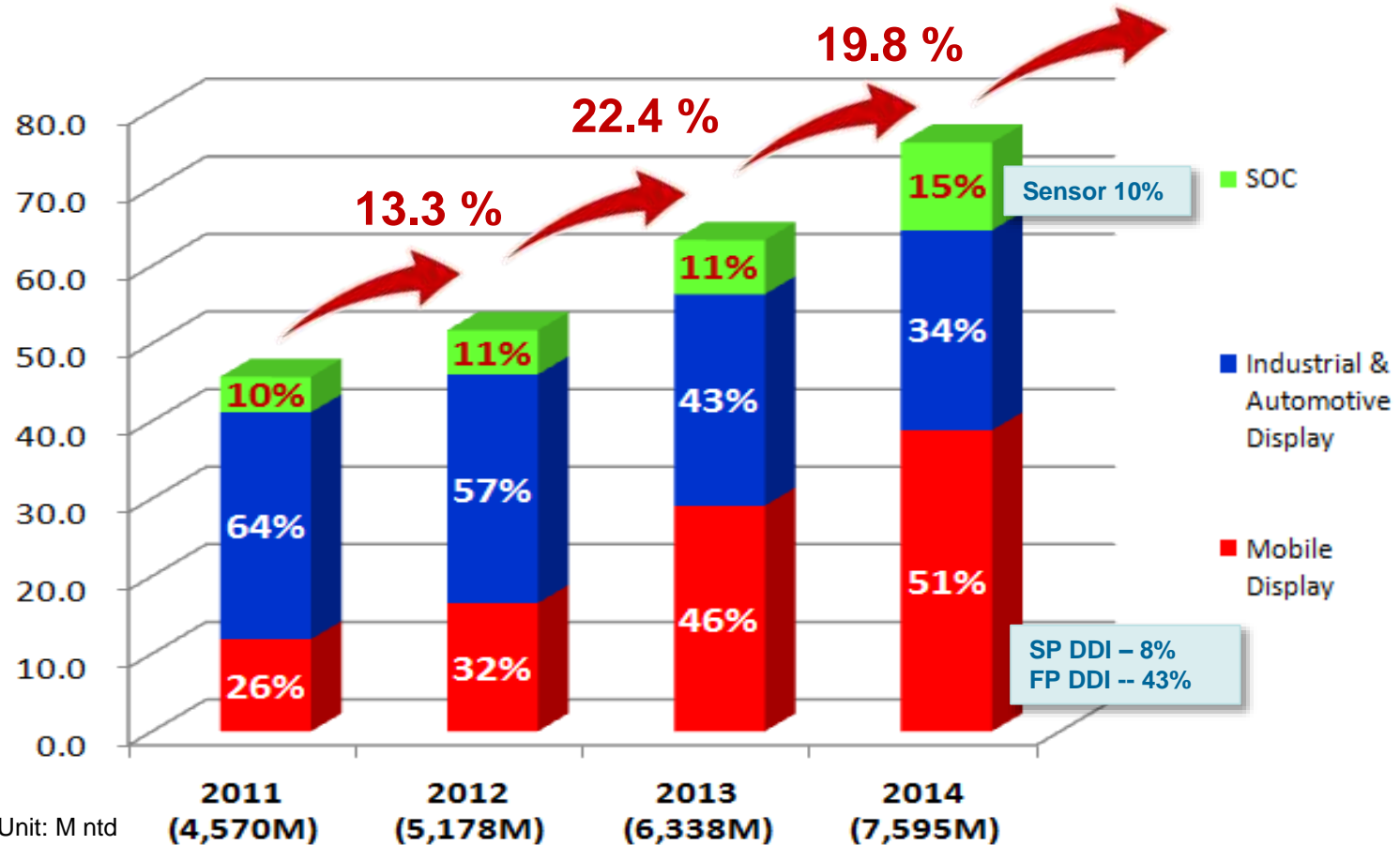

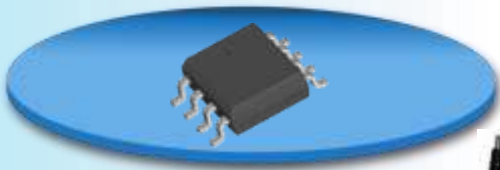
