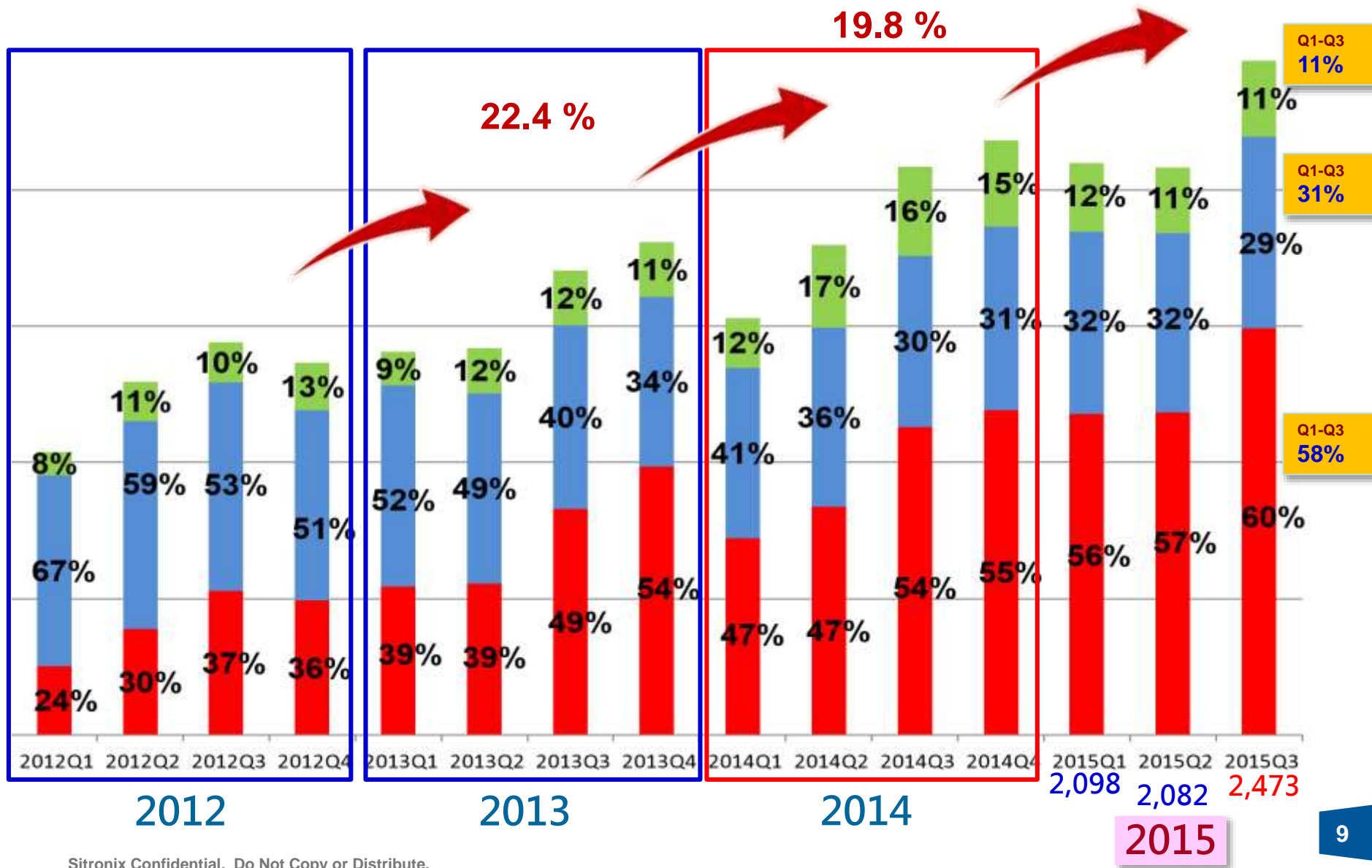

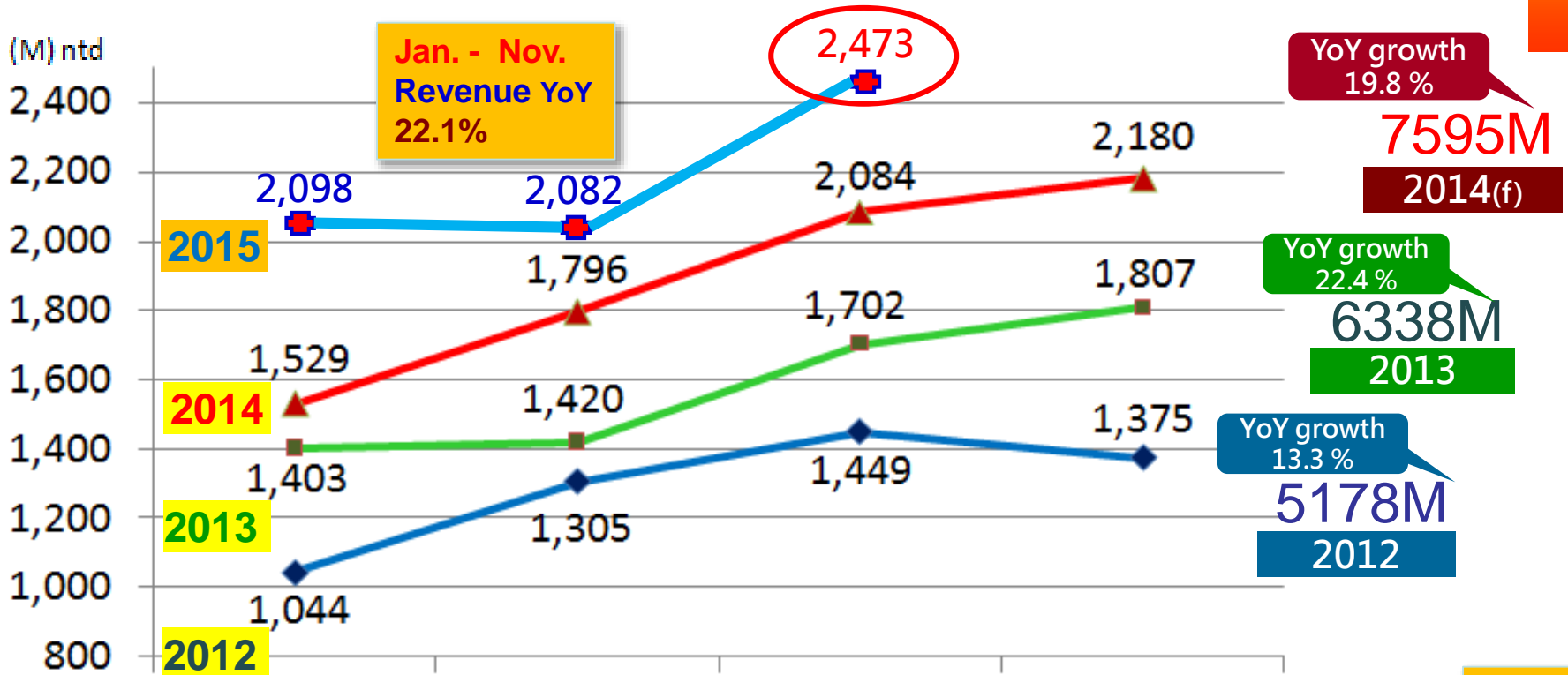

# Revenue by product type (quarterly) 季營業額依產品別



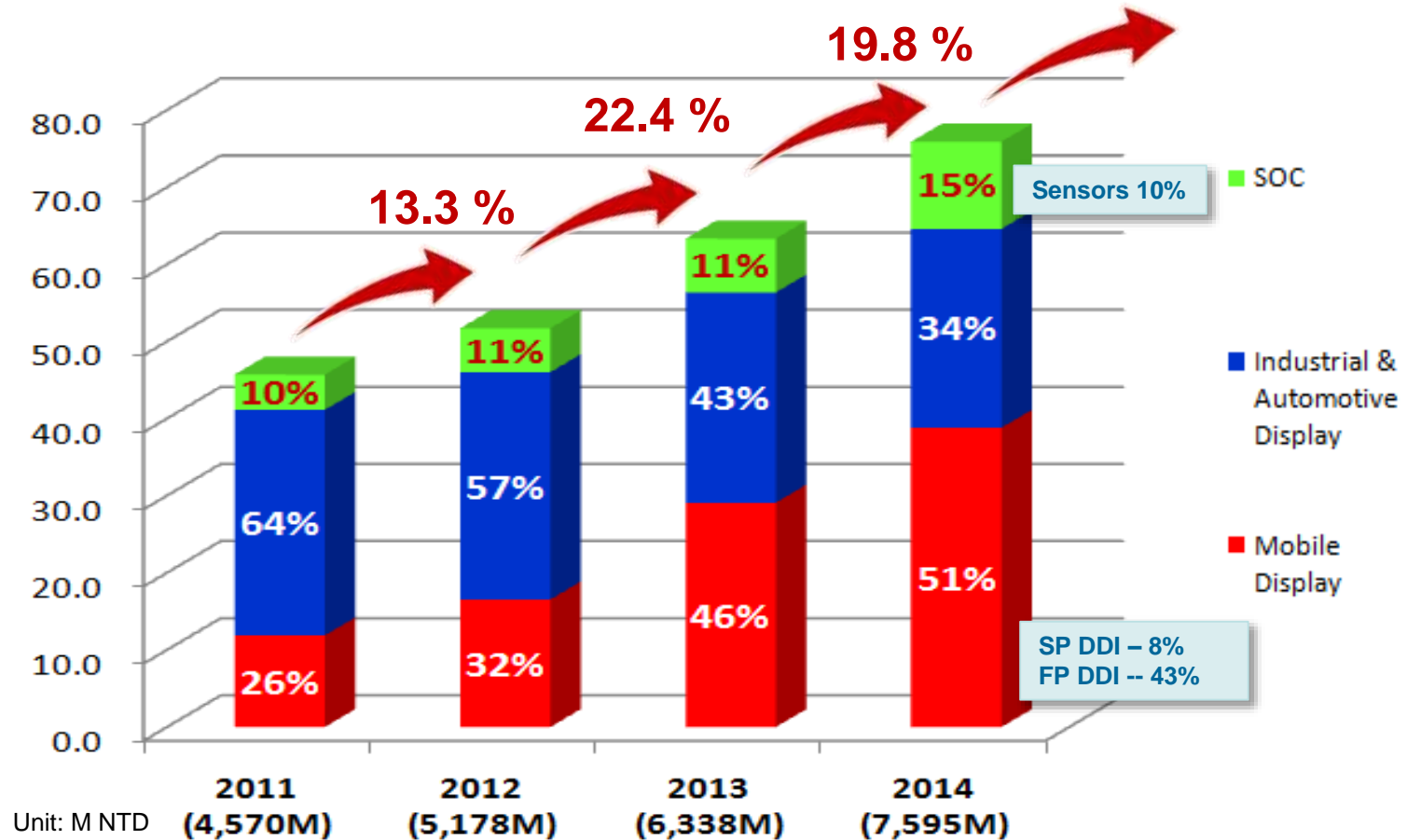

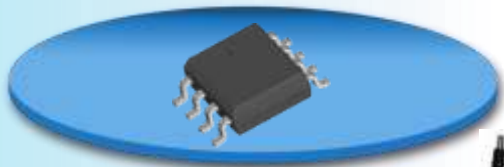
